**HAVING REGARD TO** Decree of the President of the Republic No. 445 dated 28.12.2000;

**HAVING REGARD TO** Art. 2 and 12 of the Decree of the President of the Council of Ministers issued on 9 April 2001, "Uniformità di trattamento sul diritto agli studi universitari" [uniformity of treatment regarding the right to university education];

**HAVING REGARD TO** the Regulations for Administration, Finance and Accounting, issued with Rectoral Decree n. 828 prot.n.7766 of 14/03/2014, and specifically articles 75 and 79;

**HAVING REGARD TO** the letter prot.n. 20270 of 10/03/2017, with which the representatives of the company Dalmine S.p.A., Barbara Stele and Maurizio Sclavi, have expressed the intention of donating to the Politecnico di Milano the amount of € 45.570,00 to promote study activities in the field of engineering, through the award of 15 scholarships in the name of "Roberto Rocca" to students enrolled in the academic year 2016/2017 in the first and second year of the Laurea Magistrale (equivalent to Master of Science) in the of Engineering programs of the Politecnico di Milano;

**HAVING REGARD TO** D.Dir. No. 1249, prot. No. 21587, dated 15/03/2017 stating the acceptance of the donation decided by the company Dalmine S.p.A.;

**HAVING REGARD TO** the resolution of the Board of Governors of 28/03/2017;

### **HEREBY DECREES**

The issue of the call for applications **for 15 "Roberto Rocca"** scholarships for the academic year 2016/2017.

#### **art. 1**

#### **Recipients and features of the scholarships**

The competition is open to students who in the academic year 2016/2017 are enrolled in the Laurea Magistrale (equivalent to Master of Science) in the Schools of Engineering of the Politecnico di Milano, by the closing date of this call for applications.

**art. 2**  
**Admission requirements**

The n. 15 scholarships, for a total value of € 42.000,00 net of the taxes paid by the university, are divided as follows:

**8 scholarships**, for € 2.800,00 gross each, net of the taxes paid by the Politecnico di Milano, reserved to students **enrolled in the academic year 2016/2017** in Laurea Magistrale (equivalent to Master of Science) programmes in:

**art. 3**  
**Participation procedures**

Applicants must submit their request for participation through the specific section in the Online Services <http://www.polimi.it/onlineservices> (Benefits and agreements> Economic benefits) **no later than 12.00 noon (Italian time) on 28 April 2017**.

Applicants must attach, via the specific procedure, in PDF format with a maximum of 10 MB each:

1. Curriculum Vitae et Studiorum

The files must be named as Surname-Name-Type of document.pdf (for example Rossi-Mario-CV.pdf)

The application is complete with the submission of the request for participation in this call for applications and implies the acceptance of its rules and regulations.  
Applicants are responsible for checking the procedure is properly completed.

Once the application has been completed and submitted it may no longer be changed. Applicants will be allowed to delete the request and submit it again (ex novo) before the deadline.

Failure to complete the application or to submit it means applicants will be excluded from the selection process.

**The application must be completed, under penalty of exclusion from the competition on the site [www.robtorocca.org](http://www.robtorocca.org) by the closing date of the call for applications.**

#### **art. 4** **Judging panel**

The scholarships will be awarded according to a ranking list created by a Judging Panel designated after the expiration date of the call by a Decree of the Manager.

The Judging Panel considers that none or a part of the candidates is to be considered eligible, all or part of the scholarships will not be assigned.

#### **art. 5** **Selection procedures**

The selection of the winners will be carried out in two stages.

- 1<sup>to</sup> stage: the students admitted to the competition for meeting the requirements specified in Art. 1 and 2 shall take an on-line test of logic and verbal skills.  
A ranking will be drawn up based on the outcome of the test and the evaluation of the curriculum vitae et studiorum. A small number of applicants will be admitted to the next stage, in proportion to the number of scholarships available;
- 2<sup>to</sup> stage: applicants who have passed the 1<sup>a</sup> stage shall have an interview with the Commission at the Dalmine offices (BG), p.za Caduti 6 July 1944, No.1.

**On the basis of the outcome of the interview alone, the final ranking will be drawn up and the winners will be declared.**

#### **art. 6** **General rules**

**Combination of economic aid:** The scholarship cannot be combined with other forms of economic aid offered by the Politecnico or other public or private organisations for the

academic year of reference of this call for applications. The scholarship may be combined with contributions for international mobility offered by the Politecnico or other public or private organisations. The scholarship may also be combined with exemption from payment of tuition fees and contributions.

**Revocation:** the scholarship can be revoked if the recipient is subject to disciplinary sanctions. It is still subject to revocation in case of waiver the studies and transfer to another university, current year.

**Award:** the scholarship money will be paid in one instalment. Winners will be informed of the scholarship award via an e-mail sent to their university e-mail address after the publication of the student ranking list. No later than 10 days from receiving the e-mail, the winners must sign and send the specific forms they will find attached to the award notification.

**Waiver:** if the winner waives the scholarship, it will be assigned to the next applicant in the ranking.

**Taxation:** the awarded prizes are subject to the current laws governing the taxation of scholarships. The sum paid as the degree prize is to be treated as income comparable to income from employment for taxation purposes. The tax due by the Politecnico di Milano is IRAP (equal to 8.5% of the value of the scholarship).

**Self-certification of data:** if controls by the Politecnico di Milano establish that the information supplied was false, all benefits obtained will be withdrawn.

#### **art. 7**

#### **Processing of personal data**

Pursuant to Legislative Decree 196 dated 30.06.2003, the Undergraduate and Graduate Student Service (the Data Controller of the supplied personal data), guarantees that the data will be used only to fulfil the obligations related to this procedure.

Personal data supplied to Dalmine S.p.A. with specific authorisation under Legislative Decree 196/2003, including sensitive data, may be used by the company for staff search and selection purposes.
