**HAVING REGARD** to the Decree of the President of the Republic 28.12.2000, n. 445;

**HAVING REGARD** to Articles 2 and 12 of Ministerial Decree of 9 April 2001, "Equal treatment regarding the right to higher education";

**HAVING REGARD** to Regulations for Administration, Finance and Accounting, issued by Rectoral decree n. 828 prot.n. 7766 of 14/03/2014 and in particular Articles 75 and 79;

**HAVING REGARD** to letter prot.n. 70556 of 26/07/2017, by which Mr. Angelo Costa, representative of the company Arriva Italia srl. has expressed its intention to give the Politecnico di Milano the total amount of € 21.700,00 to promote the allocation of n.1 scholarship named "Leopoldo Montanari" for students enrolled in Laurea magistrale (equivalent to Master of Science) in Ingegneria Civile - Civil Engineering field of specialization Transportation Infrastructures of Politecnico di Milano;

**HAVING REGARDS** to Executive Decree n. 4629 protocol n. 70937 of 27/07/2017 by which is declared the donation acceptance provided by the Arriva Italia srl.;

## **HEREBY DECREES**

The issuance of competition notice for n. **1 scholarship "Leopoldo Montanari" a.y. 2017/2018.**

### **art. 1**

#### **Recipients and scholarship features**

The scholarship, with gross amount of **€ 10,000**, deductible expenses excluded charged to Politecnico di Milano, are intended for **students enrolled in a.y. 2017/2018**, by the end of this Notice, **in the 1st year of Laurea Magistrale** (equivalent to Master of Science) in Ingegneria Civile - Civil Engineering field of specialization Transportation Infrastructures of Politecnico di Milano

**Scholarship can be renewed** for the same amount for the next academic year if requirements of Art. 5 of this Notice are met.

**Requirements for participation**

The competition is open to students enrolled in a.y. 2017/2018 in the 1st year of Laurea Magistrale (equivalent to Master of Science) in Ingegneria Civile - Civil Engineering field of specialization Transportation Infrastructures of Politecnico di Milano that meet the following conditions:

1. enrolment to a Laurea (equivalent to Bachelor of Science) in Engineering programme of Politecnico di Milano of the a.y. 2014/2015;
2. Laurea (equivalent to Bachelor of Science) degree final score of at least 100/110;
3. income range of a.y.2016/2017 equal or less to 4th

**art. 3**

**How to participate**

Candidates are required to submit the application form through the dedicated function available from On-line services <http://www.polimi.it/servizionline> (Benefits and agreements> Economic benefits) **within 12.00 noon (Italian time) of 06 October 2017.**

The closure of the on-line application is equivalent to send the participation application for this Notice of competition and implies acceptance of its contents.  
It is responsibility of the candidate to verify the correct conclusion of the procedure.

After closure of the Notice, application cannot be changed any more. The candidate can delete the application and resubmit a new one before the Notice deadline.

Failure to close the application or its incompleteness will implies the exclusion from the evaluation procedure.

**art. 4**

**Granting of scholarship**

**The assignment** of scholarships will be decided on the basis of a first ranking list made by the Area Sviluppo e Rapporti con le Imprese.

This ranking list will be drawn up taking into account the Laurea (equivalent to Bachelor of Science) degree final score.

The degree final score 110/110 cum Lode will be counted as 113/100

In the event of equal marks, priority shall be given to the candidate with the lowest income.

In case of further equal values, the younger candidate will come first.

All the scholarships of this competition or part of them could not be assigned, in the event that all or part of the candidates will not be considered eligible.

**art. 5**  
**Renewal of scholarships**

The recipient of “Leopoldo Montanari” scholarship for the a.y. 2017/2018 can obtain **the renewal of scholarship** for the next academic year if they meet the conditions below:

- **Be enrolled in the a.y. 2018/2019**, within time schedule deadline of academic year 2018/2019 in Ingegneria Civile - Civil Engineering field of specialization Transportation Infrastructures;
- registration of at **least 48 CFU** regularly registered and useful for graduation within 30 September 2018

The above-mentioned conditions will be verified ex officio by the Area Sviluppo e Rapporti con le Imprese, it allows the automatic renewal of the scholarship.

**art. 6**  
**General Rules**

**Cumulability** - The scholarship can not be combined with other forms of financial aid awarded by Politecnico in particular with benefits involving the right to higher education for the relevant academic year of this Notice. The scholarship can however be combined with contributions for international mobility provided by Politecnico or other public or private entity. The scholarship can also be combined with exemptions from university fees and contributions.

**Revocation:** the scholarship can be revoked if the recipient is subject to disciplinary sanctions. It is still subject to revocation in case of waiver the studies and transfer to another university, current year.

**Cancellation:** in the event of cancellation made by the winner, the scholarship is awarded to the first suitable candidate that follows in the ranking list.

**Allocation:** reserve assignment of the scholarship will be notified to the winners via institutional e-mail address of the University. Real allocation of the scholarship and its next possible renewal will be notified to the winners via institutional e-mail address of the University. Within 10 days from receipt of such notifications, the winners will have to send, signed for acceptance, the dedicate forms that they will get attached. The scholarship will be allocated with a single instalment by Politecnico di Milano.

**Tax treatment:** assigned contributions are subject to tax purposes and applicable legislation for what concern scholarships. The allocated amount for scholarship can be considered as income from salaried employment and therefore it undergoes the same tax treatment. The expenses charged to Politecnico di Milano corresponds to IRAP rate equal to 8,5% of the amount of the scholarship.
