HAVING REGARD to the Decree of the President of the Republic 28.12.2000, n. 445;

HAVING REGARD to Articles 2 and 12 of Ministerial Decree of 9 April 2001, "Equal treatment regarding the right to higher education";

HAVING REGARD to Regulations for Administration, Finance and Accounting, issued by Rectoral decree n. 828 prot.n. 7766 of 14/03/2014 and in particular Articles 75 and 79;

HAVING REGARD TO letter prot. no. 92909 dated 10/10/2017, in which Engineer Giorgio Sabelli, legal representative of Istituto di Certificazione e Marchio di Qualità per Prodotti e Servizi per le Costruzioni [Certifying and Quality Label Institute for Construction Products and Services] expressed his intention of donating to the Politecnico di Milano the amount of €2,000.00 to promote study activities in the field of engineering through the award of a degree prize to graduates in the academic year 2016/2017 in the Laurea Magistrale (equivalent to a Master of Science) in Building Engineering and in Building and Architectural Engineering and in the single-cycle Laurea Magistrale (equivalent to a Master of Science) in Building Engineering/Architecture of the Politecnico di Milano;

HAVING REGARD TO Director Decree no.7168 prot. no. 106830 dated 15/11/2017, stating the acceptance of the donation decided by Istituto di Certificazione e Marchio di Qualità per Prodotti e Servizi per le Costruzioni;

HEREBY DECREES

The issue of the call for applications for no. 1 "Paride Passerini" – year 2017 - degree prize.

art. 1

Features of the degree prize and beneficiaries

The degree prize (€2,000.00 before tax and inclusive of the taxes owed by the Politecnico di Milano) will be awarded to the best degree thesis addressing matters related to:

"Sustainable building design, construction and production solutions according to consolidated parametric protocols"

The theses may address:

- the efficacy of sustainable design solutions compared to traditional design solutions, in performance terms;
- the conscious and innovative use of materials and/or technological systems;
- the optimization of the building plant system;
- the economic impact of sustainable design solutions, in terms of both planning, execution, management and disposal;
- the analysis of and comparison between reference protocols and the efficacy thereof on sustainability;
- the study and implementation of sustainability certification systems both for buildings and products;
- the analysis and assessment of the technological and economic impact of certifications on the market, both in terms of improvement of construction standards and of the widespread use of sustainability models in construction.

The call is for graduates between April 2017 and December 2017 in the Laurea Magistrale (equivalent to a Master of Science) in Building Engineering and in Building and Architectural Engineering and in the single-cycle Laurea Magistrale (equivalent to a Master of Science) in Building Engineering/Architecture of the Politecnico di Milano.

art. 2

Participation procedures

Candidates are required to submit the application form through the dedicated function available from On-line services <http://www.polimi.it/servizionline> (Benefits and agreements> Economic benefits) **within 12.00 noon (Italian time) of 26 January 2018.**

The application is complete with the submission of the request for participation in this call for applications and implies the acceptance of its rules and regulations.

Applicants are responsible for checking the procedure is properly completed.

Once the application has been completed and submitted it may no longer be changed. Applicants will be allowed to delete the request and submit it again (ex novo) before the deadline.

Failure to complete the application or to submit it means applicants will be excluded from the selection process.

Applicants must attach, through the specific procedure:

- the degree thesis in pdf format, maximum 10 MB

The file must be named as Surname-Name-Type of document.pdf (for example Rossi-Carlo-Tesi.pdf)

Applicants must authorise the supply, in electronic form, of their degree theses to Istituto ICMQ and its associates, for consultation and filing in the Institute's library, exempting the Politecnico di Milano from any liability deriving therefrom and authorising the university to give ICMQ the details of the applicants and winners of the Paride Passerini prizes.

In case of theses with more than one author, each co-author who intends to compete for the award will submit a separate application.

art. 3 **Judging Panel**

The awarding will be decided by a Judging Panel designated after the expiration date of the call by a Decree of the Manager.

In case of an ex-aequo, the Judging Panel may divide the prize among several candidates, provided the conditions referred to in art. 1 of the call are met.

The Judging Panel reserves the right to not award the prize of the Call if the candidates are not considered suitable.

art. 4 **General rules**

Cumulability: the degree prize cannot be added to other prizes awarded for the same degree thesis.

Renunciation: if the winner renounces the prize, it will be awarded to the next highest ranking applicant in the ranking list.

Award: the winner will be informed of the degree prize award via an e-mail sent to his/her university e-mail address. No later than 10 days from receiving the e-mail, the winner must sign for acceptance and send the specific forms s/he will find attached to the award e-mail.

The Politecnico di Milano shall award the prize in a single instalment.

Taxation: the prize awarded is subject to the current laws governing the taxation of scholarships. The sum paid as the degree prize is to be treated as income comparable to income from employment for taxation purposes. The tax due by the Politecnico di Milano is IRAP (equal to 8.5% of the value of the degree prize).
