HAVING REGARD TO the Decree of the President of the Republic no. 445, dated 28.12.2000;

HAVING REGARD TO Art. 2 and 12 of the Decree of the President of the Council of Ministers issued on 9 April 2001, "Uniformità di trattamento sul diritto agli studi universitari" [uniformity of treatment regarding the right to university education];

HAVING REGARD TO the Regulations for Administration, Finance and Accounting, issued with D.R. no. 828 prot. no. 7766 dated 14/03/2014 and, in particular, articles 75 and 79;

HAVING REGARD TO the proposal of the Permanent Student Commission for the establishment of scholarships for sporting merit;

HAVING REGARD TO the Remodulation of the Merit Fund approved by the Board of Governors, dated 22/07/2014;

HAVING REGARD TO the availability of funds raised in the event PolimiRun 2018;

HEREBY DECREES

The issue of the call for **applications for 32** "**Meriti Sportivi**" scholarships for the 2018/2019 AY.

art. 1

Recipients and features of the scholarships

The n.32 scholarships for the gross amount of **€2,500 each**, including costs borne by the Politecnico di Milano, **are addressed** to:

- -newly enrolled students in all programmes in the 2018/2019 AY
- -students enrolled in Laurea (equivalent to a Bachelor of Science) programmes from the 2015/2016 AY
- -students enrolled in Laurea Magistrale (equivalent to a Master of Science) programmes from the 2016/2017 AY
- -students enrolled in the single-cycle Laurea Magistrale (equivalent to a Master of Science) programmes from the 2013/2014 AY

who have practised, at a high level, sports disciplines recognised by CONI.

Students who intend to participate must be enrolled in the 2018/2019 AY within the closing date of the call.



The competition is also open to students who are about to graduate, who are thus not required to register for the 2018/2019 AY and who have paid all their tuition fees.

art. 2 Admission requirements

Applicants enrolled in the 2018/2019 AY must have obtained the academic qualification for admission to the enrolment with the following marks:

Applicants enrolled in academic years prior to the 2018/2019 AY must have taken and duly recorded in their career before the closing date of the call an average number of CFU useful for graduation as per the table:

Individual sports

participation in the 2017/2018 or 2018/2019 season of National Championships and National Youth Championships of the specialty or in international events of a higher level.

Team sports

participation in the 2017/2018 or 2018/2019 season with their team in the Federal Championships at the National level

or

participation in the 2018/2019 season with the teams of Politecnico di Milano in the Federal Championships at the Regional level

art. 3 Participation procedures

Applicants must submit their request for participation through the specific section in the Online Services <u>http://www.polimi.it/onlineservices</u> (Benefits and agreements> Economic benefits) **no later than 12.00 noon (Italian time) on 06 November 2018.**

Applicants must attach, via the specific procedure, in PDF format with a maximum of 10 MB each:

- 1. copy of the certificate of membership of their sports club
- 2. self-certification of the competitions in which they have taken part
- 3. self-certification of the sporting results achieved to be submitted to the Panel for allocation of the scholarship

The files must be named as Surname-Name-Type of document.pdf (for example Rossi-Mario-certificate.pdf)

The application is complete with the submission of the request for participation in this call for applications and implies the acceptance of its rules and regulations. Applicants are responsible for checking the procedure is properly completed.

After closure of the Notice a receipt can be printed and the application cannot be changed any more. The candidate can delete the application and resubmit a new one before the Notice deadline.

Failure to complete the application or to submit it means applicants will be excluded from the selection process.

art. 4 Judging Panel

Allocation of scholarships is decided according to a ranking prepared by a judging panel that will be appointed by a Decree signed by the Manger.



To prepare the ranking list, the judging panel has up to 18 points that will be assigned according to the criteria listed below:

- academic merit:

Those enrolled in Laurea (equivalent to a Bachelor of Science) and Laurea Magistrale (equivalent to a Master of Science) (single cycle.) programmes in the 2018/2019 AY MAX 1 point	Points = (state exam marks –95) / 5
Those enrolled in Laurea Magistrale (equivalent to a Master of Science) programmes in the 2018/2019 AY MAX 5 points	Points = (Laurea (equivalent to a Bachelor of Science) graduation marks - 95) / 3
Those enrolled prior to the 2018/2019 AY MAX 5 points	Points = (average – 25)

- assessment of the level of achievements and growth prosp CFU in their sport up to a maximum of 10 points;
- membership of a federal or university Politecnico di Milano team up to a maximum of 3 points.

In the case of a tie, priority will be given to those not having won the "Meriti Sportivi 2017/2018 AY" scholarship.

In the event of a further tie, the younger applicant will prevail.

All the scholarships of this competition or part of them could not be assigned, in the event that all or part of the candidates will not be considered eligible.

art. 5 General rules

Cumulability –This scholarship may not be combined with other forms of financial assistance awarded by the Politecnico, in particular with Diritto allo Studio benefits, for the relevant academic year of this Call. The scholarship can however be combined with contributions for international mobility provided by Politecnico or other public or private entity. The scholarship can also be combined with exemptions from university fees and contributions.



Revocation: the scholarship can be revoked if the recipient is subject to disciplinary sanctions. It is still subject to revocation in case of waiver the studies and transfer to another university, current year.

Award: the scholarship money will be paid in one instalment. Winners will be informed of the scholarship award via an e-mail sent to their university e-mail address after the publication of the student ranking list. No later than 10 days from receiving the e-mail, the winners must sign for acceptance and send the specific forms they will find attached to the award e-mail.

Waiver: if the winner waives the scholarship, it will be assigned to the next applicant in the ranking.

Taxation: the prize awarded is subject to the current laws governing the taxation of scholarships. For taxation purposes, the sum paid for the scholarship is to be treated as income comparable to income from employment. The tax due by the Politecnico di Milano is IRAP (equal to 8.5% of the value of the scholarship).

Self-certification of data: if controls by the Politecnico di Milano establish that the information supplied was false, all benefits obtained will be withdrawn.

INFORMATION PURSUANT TO ARTICLE 13 OF THE EUROPEAN GENERAL DATA PROTECTION REGULATION

Through this document, the Politecnico di Milano (hereinafter also called Polytechnic), as Data Controller, with offices located in Piazza Leonardo da Vinci 32, 20133 Milan -General Management -, informs you with regard to the processing of your personal data, in compliance to Regulation (EU) 2016/679 of the European Parliament and Council dated 27 April 2016 on the protection of individuals regarding the processing of personal data and related implementing legislation (hereinafter also called the Regulations).

The Data Processor, of the data provided by you, is the Director of the Area Sviluppo e Rapporti con le Imprese.

A. PERSONAL DATA COLLECTED

The personal data collected and processed by the Polytechnic, which regards you, is the following: (a) the data you communicated at the time of registration or enrollment, such as name, surname, date and place of birth, sex, social security number, nationality, address of residence, telephone and IT addresses, qualifications; (b) the data collected at the time of submission of the application, in particular the data relating to your academic career, qualifications achieved, data relating to your sportives activities, as well as the data contained in your self-certification

B. PURPOSE AND METHOD OF PROCESSING

Your personal data may be processed:

1. to verify eligibility requirements to participate in the competition according to the criteria set out in this announcement and for any other purpose required by law, also with the aim of processing statistical information.

In relation to the aforementioned purposes, data processing by the Politecnico di Milano will take place using manual, computerized and electronic tools in a relevant manner and limited to what is necessary with respect to the purposes for which they are processed and, in any case, in order to guarantee the maximum security and confidentiality and, always, in full compliance with the legislation in force. The Politecnico will take all measures to promptly correct inaccurate data in relation to the processing purposes.

With reference to the particular data, the processing will be carried out in a proportionate manner with regard to the aim pursued, while adopting appropriate and specific measures to protect your fundamental rights.

C. COMPULSORY AND NON-COMPULSORY DATA

Providing data, for the purposes referred to in paragraph B. point 1, is mandatory and any refusal to provide such data involves the inadmissibility of the application submitted by the student and the immediate exclusion from the procedure. Providing data for the purposes referred to in paragraph B. point 2 is optional and any refusal to provide data does not lead to any consequences.

D. DATA CIRCULATION AND COMMUNICATION

Your personal data will be passed on to the Polytechnic employees who will be authorized to process this data, or to natural or legal persons who provide consulting services or



collaborate with the Polytechnic for the purpose of providing the selection procedures as foreseen by the competition announcement.

E. RETENTION AND POSSIBLE TRANSFER OF PERSONAL DATA

Your personal data will be stored at the Politecnico di Milano. Your data will not be transferred to a third country.

F. PERSONAL DATA PERIOD OF RETENTION

Your personal data will be kept for the time strictly necessary to guarantee access to the right to study benefits, unless the retention of data for a longer period is necessary for archiving purposes in the public interest, for scientific or historical research or for statistical purposes. Should data retention be needed for longer periods, the Polytechnic guarantees compliance with the principle of data minimization pursuant to art. 89, paragraph 1 of the Regulations.

G. YOUR RIGHTS

We would like to remind you that you have the right:

- to obtain information in relation to the ways in which your data is processed and any other information required by art. 15 of the Regulations (right of access)

- to obtain the correction of inaccurate personal data concerning you pursuant to art. 16 of the Regulations (rectification right)

- to obtain a limitation on the processing of personal data concerning you pursuant to art. 18 of the Regulations (processing restriction right);

- to oppose the processing of your personal data in the cases and under the conditions provided for by art. 21 of the Regulations (right of opposition)
