**HAVING REGARD** to the Decree of the President of the Republic 28 December 2000, n. 445;

### **HEREBY DECREES**

The issuance of the Call for n.1 degree award " Gabriele Corbelli " year 2018.

#### **art. 1**

#### **Award characteristics and recipients**

The degree award, with gross amount of **€ 1.500,00** net of any charges payable to the Politecnico di Milano, is for students that have been graduated in Laurea Magistrale (equivalent to Master of Science) in Engineering programmes at Politecnico di Milano who have applied for the PhD at Politecnico di Milano.

#### **art. 2**

#### **Requirements for participation**

Applicants must possess the following requirements by the closing date of this call:

- Titolo di laurea magistrale in: Laurea Magistrale (equivalent to Master of Science) degree in:
  - Biomedical Engineering - Ingegneria Biomedica
  - Chemical Engineering - Ingegneria Chimica
  - Energy Engineering - Ingegneria Energetica
  - Engineering Physics - Ingegneria Fisica
  - Materials Engineering and Nanotechnology - Ingegneria dei Materiali e delle Nanotecnologie
- Enrolment in the Laurea Magistrale (equivalent to Master of Science) programme in the a.y.2016/2017
- Laurea Magistrale Degree obtained in the period July 2018 - October 2018 with graduation mark not less than 110/110 cum Lode

The above-mentioned requirements will be verified ex officio by the Area Sviluppo e Rapporti con le Imprese.

### **art. 3** **How to participate**

Candidates are required to submit single application form , through the dedicated function available from On-line services <http://www.polimi.it/servizionline> (Benefits and agreements> Economic benefits) **within 12.00 noon (Italian time) of 25 January 2019.**

Applicants must submit, in PDF format max 10 MB every, through the specific procedure:

1. the degree thesis
2. a brief report on the his own professional objectives and how he intends to make a positive contribution to society

The files must be named with Surname-Name-Kind of document.pdf (for example Rossi-Mario-thesis.pdf)

The closure of the on-line application is equivalent to send the participation application for this Call and implies acceptance of its contents.

It is responsibility of the candidate to verify the correct conclusion of the procedure.

After closure of the Notice a receipt can be printed and the application cannot be changed any more. The candidate can delete the application and resubmit a new one before the Notice deadline.

Failure to close the application or its incompleteness will implies the exclusion from the evaluation procedure.

In case of graduation work with multiple authors, each co-author, that wants to participate to allocation of the award, must submit individually the application form.

### **art. 4** **Judging Panel**

The awarding will be decided by a Selection Committee appointed after Call deadline by Executive Decree.

The candidates will be invited to participate in an interview at Politecnico di Milano.

The interview will be held in Italian approximately in March 2019.

Applicants who do not attend the interview will be automatically excluded from the selection.

To draw up the ranking list the Judging Panel has a maximum of 100 points, which will be assigned according to the following criteria:

- Up to 60 points for the interview
- Up to 20 points for the degree thesis
- Up to 20 points for the report

Priority will be given to candidates with a sincere interest in making a positive contribution to society.

The judging panel may not award the prize if it believes none of the submitted thesis deserve it.

#### **art.5** **General Rules**

**Combination:** the degree award cannot be combined with other awards received for the same degree thesis.

**Cancellation:** in the event of cancellation made by the winner, the allocation is awarded to the first suitable candidate that follows in the ranking list.

**Allocation:** the award will be allocated with a single instalment by Politecnico di Milano. The award allocation will be notified to the winners via institutional e-mail address of the University. Within 10 days from receipt of such notifications, the winners will have to send, signed for acceptance, the dedicate forms that they will get attached to the allocation communication.

**Tax treatment:** assigned contributions are subject to tax purposes and applicable legislation for what concern scholarships. The allocated amount for scholarship can be considered as income from salaried employment and therefore it undergoes the same tax treatment. The expenses charged to Politecnico di Milano corresponds to IRAP rate equal to 8,5% of the amount of the scholarship.

## **INFORMATION PURSUANT TO ARTICLE 13 OF THE EUROPEAN GENERAL DATA PROTECTION REGULATION**

Through this document, the Politecnico di Milano (hereinafter also called *Polytechnic*), as Data Controller, with offices located in Piazza Leonardo da Vinci 32, 20133 Milan - General Management -, informs you with regard to the processing of your personal data, in compliance to Regulation (EU) 2016/679 of the European Parliament and Council dated 27 April 2016 on the protection of individuals regarding the processing of personal data and related implementing legislation (hereinafter also called the *Regulations*).

The Data Processor, of the data provided by you, is the Director of the Area Sviluppo e Rapporti con le Imprese.

### **A. PERSONAL DATA COLLECTED**

The personal data collected and processed by the Polytechnic, which regards you, is the following: (a) the data you communicated at the time of registration or enrollment, such as name, surname, date and place of birth, sex, social security number, nationality, address of residence, telephone and IT addresses, qualifications; (b) the data collected at the time of submission of the application, in particular the data relating to your academic career, qualifications achieved, as well as the data to your degree thesis and to your report.

### **B. PURPOSE AND METHOD OF PROCESSING**

Your personal data may be processed:

1. to verify eligibility requirements to participate in the competition according to the criteria set out in this announcement and for any other purpose required by law, also with the aim of processing statistical information
2. to consent the donor, Mrs Maria Montorfano, to coordinate the award ceremony and other events linked to the degree award, in this case the association will be a separate holder of data processing

In relation to the aforementioned purposes, data processing by the Politecnico di Milano will take place using manual, computerized and electronic tools in a relevant manner and limited to what is necessary with respect to the purposes for which they are processed and, in any case, in order to guarantee the maximum security and confidentiality and, always, in full compliance with the legislation in force. The Politecnico will take all measures to promptly correct inaccurate data in relation to the processing purposes.

With reference to the particular data, the processing will be carried out in a proportionate manner with regard to the aim pursued, while adopting appropriate and specific measures to protect your fundamental rights.

### **C. COMPULSORY AND NON-COMPULSORY DATA**

#### **E. RETENTION AND POSSIBLE TRANSFER OF PERSONAL DATA**

Your personal data will be stored at the Politecnico di Milano. Your data will not be transferred to a third country.

#### **F. PERSONAL DATA PERIOD OF RETENTION**

Your personal data will be kept for the time strictly necessary to guarantee access to the right to study benefits, unless the retention of data for a longer period is necessary for archiving purposes in the public interest, for scientific or historical research or for statistical purposes. Should data retention be needed for longer periods, the Polytechnic guarantees compliance with the principle of data minimization pursuant to art. 89, paragraph 1 of the Regulations.

#### **G. YOUR RIGHTS**

We would like to remind you that you have the right:

- to obtain information in relation to the ways in which your data is processed and any other information required by art. 15 of the Regulations (*right of access*)
- to obtain the correction of inaccurate personal data concerning you pursuant to art. 16 of the Regulations (*rectification right*)
- to obtain a limitation on the processing of personal data concerning you pursuant to art. 18 of the Regulations (*processing restriction right*);
- to oppose the processing of your personal data in the cases and under the conditions provided for by art. 21 of the Regulations (*right of opposition*)
