Provisions concerning the use of personal data

According to the current legislation on privacy (Regulation EU 2016/679 "GDPR" and Legislative Decree 196/2003, as amended and supplemented by Legislative Decree 101/2018), Mandelli Sistemi SpA, with legal head office in via Caorsana 35 –29122 Piacenza, legally responsible for the storage and processing of the above mentioned data, provides the following information related to the use and processing of the data acquired at the assignment of the "Ing. Francesco Mulazzi" scholarship :

- 1) Such personal data will exclusively be used for the purpose of the competition and only for the assignment of the above mentioned scholarship;
- 2) To such end, the members of the Board will only be informed about the data which, on the basis of the competition rules, will be of interest to the Board itself for the related operations; the data list – after the assignment – will be available to the candidates at the Mandelli Sistemi Spa's Human Resources Office;
- 3) The use of the data could be carried out either manually or via IT tools following the principles according to which they have been acquired and, in any case, in order to guarantee their privacy and safety;
- 4) The candidates will be able to exercise their rights according to the articles 15-21 of the GDPR– among which we outline the right to have confirmation as to whether their data exist, to have them made available in an intelligible form, to know the logic and the scope on which their use is based, to have them cancelled, anonymized, blocked due to the infringement of the Law, updated, amended or, if needed, integrated, as well as the right to legitimately oppose their use - by sending a written communication to the legally responsible Data Controller;
- 5) The consent to the use and communication of one's personal data to the above mentioned addressees, although within the limits previously indicated, is indispensable to proceed in the operations foreseen by the competition for the assignment of the scholarship : therefore, the candidate participation will not be possible without such consent;
- 6) Mandelli Sistemi SpA, via Caorsana 35 –29122 Piacenza is the legally responsible Data Controller;

The candidates are highly recommended not to provide data from which other information may be derived such as the racial and/or ethnic origins, the religious beliefs, the political opinions, the membership to a political party, trade union, association or religious, philosophical, union organization as well as information about one's health, that is to say data that the GDPR at article 9 regards as "special categories of personal data".

Such data are in fact irrelevant with respect to the participation in the competition and cannot be dealt with unless prior authorization by the Italian Data Protection Authority.

The assignment of the scholarship can be documented by photos/videos and publicized via traditional methods as well as using Web tools. Mandelli guarantees the legal and correct use of the images thus excluding any use which may jeopardize one's personal dignity and respectability.
