**HAVING REGARD TO** the Decree of the President of the Republic no. 445, dated 28.12.2000;

**HAVING REGARD TO** articles 2 and 12 of the Decree of the President of the Council of Ministers issued on 9 April 2001, "Uniformità di trattamento sul diritto agli studi universitari" [uniformity of treatment regarding the right to university education];

**HAVING REGARD TO** the Regulations for Administration, Finance and Accounting, issued with R.D. no. 828, prot. no. 7766, dated 14/03/2014 and, in particular, articles 75 and 79;

**HAVING REGARD TO** the availability of residual funds of previous donation;

**HAVING REGARD TO** the resolution of the Board of Governors made on 16/04/2019;

**HAVING REGARD TO** the notarial deed with index no. 62331, drawn up by Studio Zabban, Notari, Rampolla & Associati;

### **HEREBY DECREES**

The issue of a call for applications for **16 scholarships** for students enrolled in a **Laurea Magistrale** (equivalent to a Master of Science) at the Politecnico di Milano in the a.y. 2019/2020.

#### **Art. 1**

##### **Recipients and features of the scholarship**

The 16 scholarships, for the gross amount of **€ 16,000** each including tax due from the Politecnico di Milano, are for students **of all Politecnico di Milano Laurea Magistrale programmes** (equivalent to a Master of Science).

#### **Art. 2**

##### **Requirements for participation**

The competition is open to that meet the following conditions within the deadline of Notice:

1. **Enrolment** in a Laurea Magistrale of Politecnico di Milano of a.y. **2019/2020**;
2. **at least 15 CFU** regularly registered and useful for graduation in his career
3. **weighted average** of the passed exams registered **not less than 27/30**

The Research, Innovation and Corporate Relations Division will attest the possession of requirements available in the computerized archive of Politecnico di Milano.

### **Art. 3** **Participation procedures**

Applicants must submit their request for participation through the specific section in the Online Services <http://www.polimi.it/onlineservices> (Benefits and agreements> Economic benefits) **by no later than 12.00 noon (Italian time) on 20 March 2020.**

The closure of the on-line application is equivalent to send the participation application for this Notice of competition and implies acceptance of its contents.  
It is responsibility of the candidate to verify the correct conclusion of the procedure.

After closure of the Notice, can print a receipt and the application cannot be changed any more. The candidate can delete the application and resubmit a new one before the Notice deadline.

Failure to close the application or its incompleteness will implies the exclusion from the evaluation procedure.

### **Art. 4** **Awarding of the scholarship**

The assignment of scholarship will be decided on the basis of a ranking list made by the Research, Innovation and Corporate Relations Division.

The ranking list will be drawn up through the allocation of a score determined by the following formula:

#### **WEIGHTED AVERAGE x REGISTERED CFU (at the deadline of the call)**

In case of further equal score, the younger candidate will come first.

All the scholarships of this competition or part of them could not be assigned, in the event that all or part of the candidates will not be considered eligible.

The winners can be invited to a meeting with the donor.

### **Art. 5** **General rules**

**Cumulability** –This scholarship may not be combined with other scholarships or forms of financial assistance awarded by the Politecnico, for the relevant academic year of this

Call. **The scholarship can however be combined with Diritto allo Studio scholarship and benefits**, contributions for international mobility provided by Politecnico or other public or private entity. The scholarship can also be combined with exemptions from university fees and contributions.

**Revocation:** the scholarship can be revoked if the recipient is subject to disciplinary sanctions. It is still subject to revocation in case of waiver the studies and transfer to another university, current year.

**Cancellation:** in the event of cancellation made by the winner, the scholarship is awarded to the first suitable candidate that follows in the ranking list.

**Allocation:** the assignment of the scholarship will be notified to the winners via institutional e-mail address of the University. Within 10 days from receipt of such notifications, the winners will have to send, signed for acceptance, the dedicate forms that they will get attached. The scholarship will be allocated with a single instalment by Politecnico di Milano.

**Tax treatment:** assigned contributions are subject to tax purposes and applicable legislation for what concern scholarships. The allocated amount for scholarship can be considered as income from salaried employment and therefore it undergoes the same tax treatment. The expenses charged to Politecnico di Milano corresponds to IRAP rate equal to 8,5% of the amount of the scholarship.

## **INFORMATION PURSUANT TO ARTICLE 13 OF THE EUROPEAN GENERAL DATA PROTECTION REGULATION**

Through this document, the Politecnico di Milano (hereinafter also called Polytechnic), as Data Controller, with offices located in Piazza Leonardo da Vinci 32, 20133 Milan - General Management -, informs you with regard to the processing of your personal data, in compliance to Regulation (EU) 2016/679 of the European Parliament and Council dated 27 April 2016 on the protection of individuals regarding the processing of personal data and related implementing legislation (hereinafter also called the Regulations).

The Data Processor, of the data provided by you, is the Director of the Research, Innovation and Corporate Relations Division.

### **A. PERSONAL DATA COLLECTED**

The personal data collected and processed by the Polytechnic, which regards you, is the following: **(a)** the data you communicated at the time of registration or enrollment, such as name, surname, date and place of birth, sex, social security number, nationality, address of residence, telephone and IT addresses, qualifications; **(b)** the data collected at the time of submission of the application, in particular the data relating to your academic career, CFU number and average.

### **B. PURPOSE AND METHOD OF PROCESSING**

Your personal data may be processed:

1. to verify eligibility requirements to participate in the competition according to the criteria set out in this announcement and for any other purpose required by law, also with the aim of processing statistical information.

In relation to the aforementioned purposes, data processing by the Politecnico di Milano will take place using manual, computerized and electronic tools in a relevant manner and limited to what is necessary with respect to the purposes for which they are processed and, in any case, in order to guarantee the maximum security and confidentiality and, always, in full compliance with the legislation in force. The Politecnico will take all measures to promptly correct inaccurate data in relation to the processing purposes.

With reference to the particular data, the processing will be carried out in a proportionate manner with regard to the aim pursued, while adopting appropriate and specific measures to protect your fundamental rights.

### **C. COMPULSORY AND NON-COMPULSORY DATA**

Providing data, for the purposes referred to in paragraph B. point 1, is mandatory and any refusal to provide such data involves the inadmissibility of the application submitted by the student and the immediate exclusion from the procedure. Providing data for the purposes referred to in paragraph B. point 2 is optional and any refusal to provide data does not lead to any consequences.

### **D. DATA CIRCULATION AND COMMUNICATION**

Your personal data will be passed on to the Polytechnic employees who will be authorized to process this data, or to natural or legal persons who provide consulting services or collaborate with the Polytechnic for the purpose of providing the selection procedures as foreseen by the competition announcement.

#### **E. RETENTION AND POSSIBLE TRANSFER OF PERSONAL DATA**

Your personal data will be stored at the Politecnico di Milano. Your data will not be transferred to a third country.

#### **F. PERSONAL DATA PERIOD OF RETENTION**

Your personal data will be kept for the time strictly necessary to guarantee access to the right to study benefits, unless the retention of data for a longer period is necessary for archiving purposes in the public interest, for scientific or historical research or for statistical purposes. Should data retention be needed for longer periods, the Polytechnic guarantees compliance with the principle of data minimization pursuant to art. 89, paragraph 1 of the Regulations.

#### **G. YOUR RIGHTS**

We would like to remind you that you have the right:

- to obtain information in relation to the ways in which your data is processed and any other information required by art. 15 of the Regulations (right of access)
- to obtain the correction of inaccurate personal data concerning you pursuant to art. 16 of the Regulations (rectification right)
- to obtain a limitation on the processing of personal data concerning you pursuant to art. 18 of the Regulations (processing restriction right);
- to oppose the processing of your personal data in the cases and under the conditions provided for by art. 21 of the Regulations (right of opposition)
