**HAVING SEEN** Presidential Decree 28 December 2000, no. 445;  
**HAVING REGARD** to articles 2 and 12 of Prime Ministerial Decree of 9 April 2001, “Equal treatment in the right to university studies”;  
**HAVING REGARD** to article 75, paragraph 2 of the Regulation for Administration, Finance and Accounting of the Politecnico di Milano, issued with Rectoral Decree no. 828 prot. no. 7766 of 14/03/2014;  
**HAVING REGARD** to the letter dated 06/02/2020 with which the company Fabbrica Energie Rinnovabili Alternative S.r.l. expresses the intention to donate to Politecnico di Milano the sum of €8,000 to promote study activity in the field of engineering through the provision of a degree award for graduates currently undertaking the Laurea Magistrale (equivalent to a Master of Science) in Energy Engineering;  
**HAVING REGARD** to the approval of the donation by the Board of the Department of Energy at the meeting on 20/02/2020;

## **D E C R E E S**

The issuance of the call for applications for the **“Francesco Cesare Fera” degree award for 2020**.

### **art. 1**

#### **Description of the degree award and recipients**

The degree award will go to the applicant who has developed the best degree thesis from those dealing with topics related to: **“Components, systems and processes based upon the use of renewable energy sources”**.

**The first person** in the ranking will be awarded a prize of **€4,000**.

**The second and third persons** a prize of **€2,000 each**.

The above amounts are gross and include costs to be paid by Politecnico di Milano.

Students who have obtained the following Laurea Magistrale (equivalent to Master of Science) from Politecnico di Milano are eligible to participate:

- in Energy Engineering
- in the period from January 2020 to April 2021

- with a graduation score of not less than 100/110

The Research, Innovation and Corporate Relations Division shall check that applicants possess the necessary requirements.

#### **art. 2**

#### **How to participate**

Applicants must submit the application by way of the specific function available from the online Services <http://www.polimi.it/servizionline> (Agevolazioni e Convenzioni > Borse di studio, premi di laurea, esoneri, bandi generici [Subsidies and Conventions > Scholarships, degree prizes, exonerations, generic notices]) **by 12pm (Italian time) on 19 May 2021.**

Candidates **must attach**, by way of the relevant procedure:

- their **degree dissertation in PDF format, with a maximum file size of 10MB**

The file must be named with Surname-First Name-Document Type.pdf (for example, Rossi-Mario-Dissertation.pdf)

Completion of the online application is equivalent to submitting an application for participation in this call for applications, and implies acceptance of its contents. It is the applicant's responsibility to check that they have properly completed the procedure.

After having completed and submitted the application, the applicant may print a receipt and the application may no longer be edited. The applicant will, however, have the option of deleting the application and submitting a fresh application before the deadline set out in this call for applications.

Failure to complete and submit the application, submitting an incomplete application or submitting inadequate documents will result in the applicant being excluded from the assessment procedure.

**In the case of theses with multiple authors, each co-author who intends to compete for the award must present their application for participation individually.**

By submitting an application, the winning applicant consents to their thesis or part thereof being published within the bounds of respect for copyright.

#### **Adjudicating Committee**

The granting of the degree award is decided based on a ranking drawn up by a Selection Committee appointed by managerial decree following the deadline of the call for applications.

The Committee will decide the ranking based on the attached thesis.

**It will be preferable to have developed contributions on wind energy as well as on the accumulation and distribution of electricity by motor propulsion.**

Provided that the requirements set out in art. 1 of the call for applications are met, the Committee may share the award among several applicants if there is an ex-aequo.

The Adjudicating Committee may not award the prize if none of the applicants are deemed suitable.

The winner may be invited to a meet-and-greet with the donor.

#### **art. 4**

#### **General rules**

**Cumulability:** the degree award is not cumutable with other awards received for the same dissertation.

**Withdrawal:** in the event of the winner withdrawing or failing to return the necessary forms by the established deadline, the prize will be awarded to the next highest applicant in the ranking.

**Payment:** the awarding of the degree award will be communicated to the winner via their official university email address. Within 10 days of receipt of this communication, the winner must return the relevant forms attached to the award notification, signed for acceptance.

The prize will be paid in a single payment from the Politecnico di Milano.

**Tax status:** the payments awarded are subject to taxation, under the legislation in force regarding study awards. The amount paid as a degree award is income considered similar to income from employment, and as such is subject to the same taxation. The taxes paid by Politecnico di Milano correspond to the IRAP rate of 8.5% of the total degree award.

#### **COLLECTED PERSONAL DATA**

#### **A. OBJECTIVES AND METHODS OF THE PROCESSING**

If the data is stored for longer periods, Politecnico guarantees compliance with the data minimisation principle under art. 89, point 1 of the Regulations.

#### **F. YOUR RIGHTS**

You have the right to:
