HAVING REGARD TO the reorganisation of the Merit Fund approved by the Board of Governors on 22/07/2014;
HAVING REGARD TO the resolution of the Board of Governors of 31/10/2023;

DECREES

The issuance of the Call for Applications for **30 scholarships for "Sports Merits" for a.y. 2023/2024**.

art. 1

Recipients and characteristics of the scholarships

The 30 scholarships, for a gross amount of € 5,000 each and inclusive of charges borne by the Politecnico di Milano, are addressed to students who, in a.y. 2023/2024, are enrolled in one of the following training courses at the Politecnico di Milano:

- Laurea (equivalent to a Bachelor of Science)
- Single-cycle Laurea Magistrale (equivalent to a Master of Science)
- Laurea Magistrale (equivalent to a Master of Science)

and who have **practiced, at high levels, sports recognised either by the Italian National Olympic Committee (CONI) or by the International Olympic Committee (IOC)**.



art. 2
Admission requirements

Students enrolled in a.y. 2023/2024 must be duly registered.

Students enrolled in academic years prior to a.y. 2023/2024 must have obtained and duly registered in their academic record, by the closing date of the Call for Applications, an average score and a minimum number of ECTSs counting towards obtaining their qualification as detailed below:

Students must also have **participated in competitions of the Sports Federations and Associated Disciplines recognized by CONI or IOC and possess the minimum requirements indicated above.**

The sports and disciplines published in the ATTACHMENT N°2 are eligible

Individual sports

Participation, in the timeframe between September 12th 2022 and October 31st 2023, in the Absolute and Absolute Youth Championships of specialties or in higher level international events.

Team sports

Participation, in the timeframe between September 12th 2022 and October 31st 2023, with their team, in Federal Championships at the national level.

art. 3 **How to participate**

Students are required to submit their application form through the specific function of the Online Services <http://www.polimi.it/servizionline> (Here the path: *Online Services > Benefits and agreements > Economic Benefits*) **by 12:00 noon (Italian time) of January 18th 2024.**

Students should attach, by way of the specific procedure, in pdf format of a maximum of 10 MB each:

1. a copy of the certificate confirming membership of their sports club;
2. certification from the federation which one belongs to regarding the contests they participated in and the athletic goals they achieved using ATTACHMENT N°1

Files must be named as follows: Surname-First Name-Document Type.pdf (for example, Rossi-Mario-CV.pdf).

Completion of the online application occurs by clicking on 'Participate', which means submitting the application to participate in this call and implies acceptance of its contents. It is the student's responsibility to check that they have properly completed the procedure.

After having completed and submitted the application, the student may print a receipt and the application may no longer be edited. The student can delete the application and submit a fresh one before the deadline set out in this Call for Applications.

Failure to complete and submit the application or submitting an incomplete application will result in the student being excluded from the assessment.

art. 4
Selection Committee

Granting the scholarships is decided based on a ranking drawn up by a Selection Committee appointed by decree signed by the Director.

Initially, a preliminary ranking based on academic merit will be created; points will be awarded for merit ranging from 3 to 24 and will be granted based on the following criteria:

Enrolled in a Laurea (equivalent to Bachelor of Science) or a single-cycle Laurea Magistrale (equivalent to Master of Science) programme in a.y. 2023/2024	From 3 to 24 points based on the test score
Enrolled in a Laurea Magistrale (equivalent to Master of Science) programme in a.y. 2023/2024	From 3 to 24 points based on the Bachelor degree
Enrolled before a.y.2023/2024	From 3 to 24 points based on the weighted average

The Judging Commission will conduct its evaluations based on the goals attained in the relevant sport, up to a maximum of 100 points, in the order of the preliminary ranking.

The diffusion index, which is the proportion of registered athletes out of the total supplied by the sum of all the federations, is taken into consideration in the final result:

When an athlete has numerous legitimate sporting performances, the one that yields the highest score is taken into consideration for ranking purposes.

In the event of a tie, priority will be given to those who did not win the scholarship for “Sports Merits a.y. 2022/2023”.

Should there still be a tie, the younger student will take precedence.

Should all or part of the students not be deemed eligible for participation, then all or part of the scholarships offered will not be awarded. In this case, the residual funds will be added to those for the following academic year.

art. 5

Payment of scholarship amounts

Scholarships are paid in a single instalment. After the publication of the ranking, all the winners of the scholarship will be notified, via their institutional e-mail address. Within 10 days of receipt of this communication, the winners must return the relevant forms attached to the award notification, signed for acceptance.

The scholarship will be paid into the account indicated by the student on their personal Online Services page, reached as follows: Dati -> Gestione delle modalità di pagamento [Information > Manage payment methods].

The winners are invited to take part in the awards ceremony held at the Politecnico di Milano.

art. 6

Combining scholarships - Revocation - Waiver

The scholarship cannot be combined with other scholarships or other forms of financial aid provided by the Politecnico for the academic year relating to this Call for Applications. Instead, the scholarship may be combined with the Diritto allo Studio scholarship and benefits, and with the international mobility contributions provided by the Politecnico or by other public or private entities. The scholarship may also be combined with exemptions from tuition fees and contributions.

The scholarship may be revoked if the beneficiary has incurred disciplinary sanctions. Moreover, it will be revoked if the student withdraws from his or her studies or transfers to another university during the year.

In the event of the winner waiving the scholarship or failing to deliver the necessary forms on time, the scholarship will be awarded to the next eligible student in the ranking.

art. 7
Taxation

The amounts paid are subject to tax, under applicable scholarship legislation. The amount paid as a scholarship is considered the equivalent of employment income, and as such is subject to the same taxation. The charges borne by Politecnico di Milano correspond to the applicable IRAP rate for that year.

art. 8
Validation of truthful statements

The Politecnico of Milan validates the truthfulness of statements given by the student based on the methods set forth by law, in particular art. 76 of Presidential Decree no. 445/2000.

In the case of untruthful statements, sanctions shall be applied pursuant to articles 75 and 76 of Presidential Decree no. 445/2000.

In any case, this is without prejudice to any disciplinary sanctions and criminal regulations that should apply, should the fact constitute a crime.

art. 9
Personal data processing

The processing of personal data is carried out in compliance with the provisions of EU Regulation of 27 April 2016, no. 679 (General Data Protection Regulation, GDPR). The “Data Controller” is Politecnico di Milano.
