THE DIRECTOR

GIVEN the participation of Politecnico di Milano in the Global E3 (Global Engineering Education Exchange) Network;

CONSIDERING the possibility to select students for an international mobility within the Network's partner Universities that is based on a careful balancing of incoming and outgoing flows;

DECREES

to issue this call for applications for maximum **10 students** who will have the opportunity to apply for an international mobility within the **Global E3 Network** for the **academic year 2025/26 (second semester)**.

Art. 1 - Recipients

This Call is aimed at all students enrolled in the:

- School of Civil, Environmental and Land Management Engineering;
- School of Industrial and Information Engineering;
- School of Architecture Urban Planning Construction Engineering - Engineering courses

Who, in the a.y. 2025/2026, within the deadline of this call, are enrolled in the third year of a Laurea programme or in the third year of a five-year single cycle programme in Building Engineering/Architecture and intend to participate in the selection for international mobility in one of the Global E3 Network partner universities <https://globale3.studioabroad.com/>.

Art. 2 – Application submission

To participate in the Global E3 selection process, the application must be approved in advance by Politecnico di Milano. Before filling the application on the Global E3 portal, applicants must express their willingness to participate through online Services <http://www.polimi.it/servizionline> (Admission applications section) > Selection procedures admission) **by 12.00 (midday) September 1st, 2025**. Politecnico will make a pre-selection based on the criteria specified below.

It is recommended to check the information/documents required for the application in advance on the Global E3 portal [Prepare to Apply > IIE Global E3 Application System](#).

The deadline for entering and validating the application on the Global E3 portal is set for **September 15, 2025**.

PLEASE NOTE:

Only application for extra-EU universities will be validated.

Art. 3 – Participation requirements and pre-selection procedure

Students who have acquired a minimum of **100 ECTS credits** with a weighted average of at least **26/30**, may participate in the pre-selection.

Qualifying ECTS credits obtained and registered in the academic profile by **August 10, 2025** will be considered.

The ranking will be formulated based upon the score determined by the formula:

WEIGHTED AVERAGE x REGISTERED ECTS CREDITS

For students with equal grade, ranking priority will be given to the student with the highest average. If the grades are still equal, priority will be given to the youngest student.

The ranking will be published on the University website by **September 4, 2025** and selected students will have to confirm their willingness to complete the application on the GlobalE3 portal by **September 6, 2025**.

Art. 4 – Contributions

Students will receive the same contribution that has been defined by Politecnico di Milano Board of Governors for students selected through the International mobility call for the a.y. 2025/2026.
